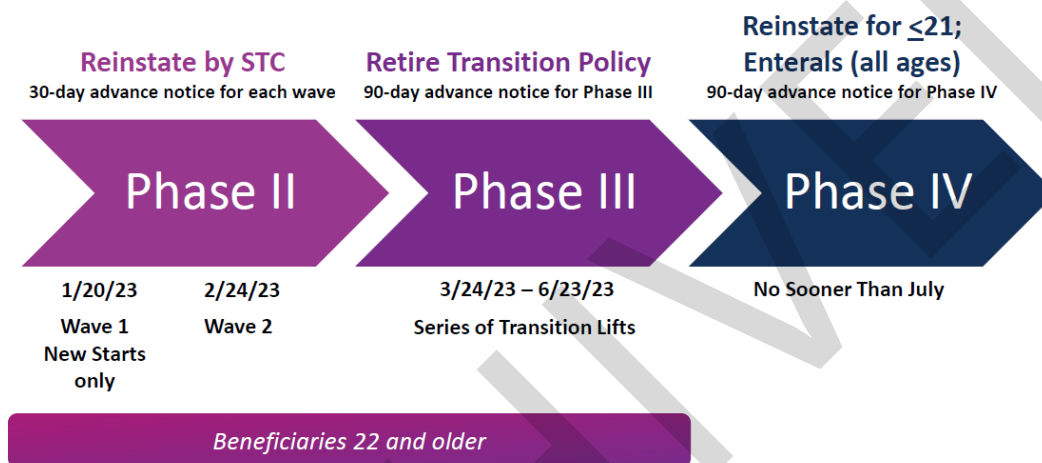

Note: Medi-Cal Rx will provide an updated graphic to reflect the reinstatement of prior authorization (PA) requirements for enteral nutrition products for beneficiaries 22 years of age and older, as well as the reinstatement of utilization management (UM) claim edits.
