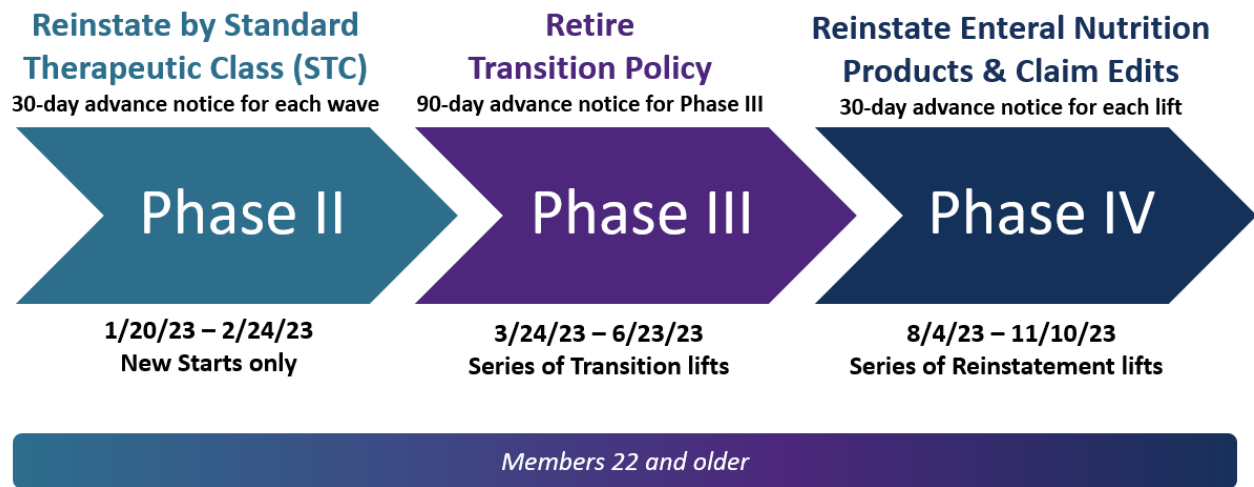




# Medi-Cal Rx Reinstatement Spotlight – December 15, 2023
